# Mandate of the New Government

- Minister's mandate letter:

- Commitment to invest in growing the economy, strengthening and growing the middle class, to improve economic opportunity and security of Canadians
- Strong focus on results informed by performance measurement, evidence and feedback from Canadians
- A different style of leadership and a higher bar for a professional government - openness and transparency, meaningful engagement, renewed sense of collaboration, improved partnerships with all levels of government, indigenous Peoples, stakeholders and public service
- Embrace the values of inclusion, honesty, hard work, fiscal prudence and generosity of spirit, to bring Canadians together

# Mandate of the New Government

- Overarching goal is to “reopen Canada’s doors to welcome those who want to contribute to our country’s success”
- Immigration and refugee policies and approaches to reflect the qualities of Canadians – “open, accepting and generous” and “welcoming those seeking refuge from conflict and war”
- “Come together to welcome newcomers who want to build a better Canada and to help those in need” to strengthen our communities

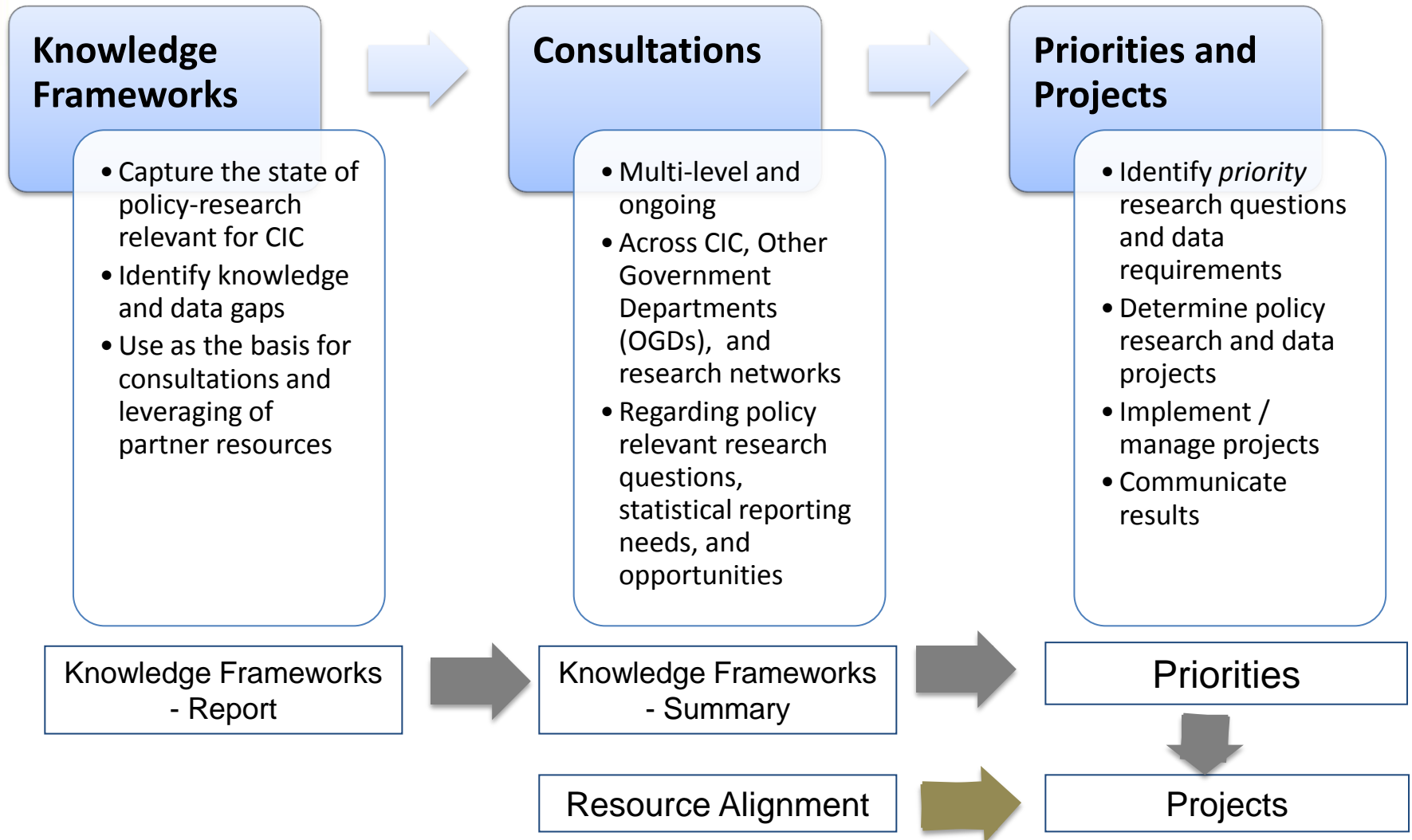
# Government Commitments

- Reflective of the election platform commitments – renewed emphasis on humanity and compassion, family and people:
  - Resettle 25,000 Syrian refugees
  - Double the number of entry applications for parents and grandparents to 10,000/year
  - Give additional points under the Express Entry system to applicants with Canadian siblings
  - Increase dependents age to 22 from 19
  - Proposal for permanent residency of new spouses entering Canada
  - Reduce processing times for sponsorship, citizenship and other visas
  - Fully restore the Interim Federal Health Program (IFHP)
  - Establish an expert human rights panel
  - Modify TFW program (remove IMIA fee to hire caregivers and establish regulations for caregiver hiring agencies)
  - Facilitate temporary entry of low risk travelers and lift visa requirement for Mexico
  - Repeal provisions in Citizenship Act that give the government the right to strip citizenship from dual nationals
  - Restore the credit given to international students for half of the time spent in Canada
  - Remove the requirement for new citizens to sign a declaration of intent to reside in Canada

# Policy Research Priorities – key research theme

- Migration of permanent and temporary residents who want to contribute to Canada's success
  - The role of immigration and temporary programs in meeting current and future labour market needs and potential displacement of Canadian-born workers
  - Social and economic outcomes of immigrants and enhancing the success of immigration programs
  - Impacts of immigration and temporary programs and program changes (e.g. Express Entry) on the economy and the integration of immigrants
  - Immigration levels and mix
  - Outcomes of those who transition from temporary status compared to those who do not
  - Impact and outcome of reforming Canada's International Student and International Mobility Programs



## Policy Research Priorities – key research theme

- Family and humanitarian migration that reunites families and offers protection to the displaced and persecuted
  - Outcomes and dynamics of resettled refugees and family class immigrants
  - Motivation of refugee claimants and outcomes of refugees landed in Canada
  - Social and human capital, and their impact on integration of refugees
  - Incidence of short and long term low income and its impact on the provision of social assistance and housing

# Policy Research Priorities – key research theme

- Newcomers and citizens participate in fostering diversity, inclusion and an integrated society
  - Foreign credential recognition(FQR)
    - Characteristics and labour market outcomes of internationally trained immigrants and comparisons to those with Canadian credentials and the Canadian-born population, as well as the speed of reaching par with Canadian born
    - Integration pathways and FQR, supports for internationally trained immigrants
    - Interprovincial and international perspectives on FQR
    - Canadian best practices in FQR service delivery, pre- and post-arrival
    - Improving recognition of foreign qualifications

- Demographic and socio-economic trends, including secondary mobility and its impact on settlement service delivery
- Integration pathways and dynamics and differences among regions of Canada, rural/urban, English/French

- Relationship between settlement/integration experiences and views of/trends towards radicalization and violence
- Integration experience and its impact on immigrant health and mental health

  - International perspectives on citizenship, focus on transnationalism and cross-national comparisons
- Official languages minority communities (OLMCs)
  - Socio-economic and demographic trends, vitality factors of OLMCs
  - Capacity, recruitment, retention, and integration strategies and best practices in OLMCs
  - Immigrant pathways: profile, progression and results

## Policy Research Priorities – key research theme

- Managed migration and facilitated travel that promotes Canadian interests and protects the health, safety and security of Canadians
  - Screening and health management, including effectiveness and efficiency of traveler screening
  - Health determinants, burden of disease, and risk factors of public health in new immigrants
  - Migration control and security management
  - Fraud prevention

# Major Knowledge Gaps for Research Priorities

- Based on the research priorities, IRCC developed an annual Policy Research and Data Plan (PRDP)
- PRDP lays out the projects IRCC plans to undertake, while reflecting the internal resource constraints and staff expertise
- PRDP is aspirational as additional resources are required for certain identified projects
- Research community can contribute significantly to major knowledge gaps

# Redesign of CIC's Foundational Analytical/Research Reporting Infrastructure

**Enhance analytical/research data integrity by ensuring data coherence, interpretability and quality of all data points emanating from all administrative systems which populate existing analytical research databases.**

- Incorporating data emanating from Global Case Management System (GCMS) and the Integrated Data Mart (IDM) into reporting infrastructure and continued exploration and exploitation of new data points from GCMS to ensure the enhancement of potential data linkages with other administrative data.

**Support CIC Data Governance Program, and the modernization of departmental data management and stewardship (co-lead with SIMB and OPMB)**

# Expanding the evidentiary base through data linkages

**Link CIC person based research data with data from Other Government Departments (OGDs) and surveys to create analytical research databases to leverage resources and to better tell the immigration, citizenship, and multiculturalism story:**

- Extension of CIC Permanent Residents landing data back to 1952
- Canadian Employer Employee Dynamic Database (CEED) : Allows for analysis at the firm, employer and employee level for PR and TR and social assistance for refugee claimants
- Immigration category in the 2016 NHS
- 2014 General Social Survey (GSS) on Victimization post-collection linkage with IMDB/Immigration Landing File (ILF) (\$)
- Canadian Community Health Survey (CCHS) linkage with IMDB/ILF
- 2016 GSS on Canadians at Work and Home, methodology of immigrant oversample (\$)
- DEMOSIM
- Provincial Health data linkages: Manitoba (Manitoba Health and Manitoba Centre for Health Policy) – under negotiation

# Statistical Reporting and External Data Release

## Departmental Statistical Reporting

- Respond to data requests in support of departmental and external research/statistical needs.
- Support reporting required for policy analysis, performance measurement, program monitoring, results reporting, academics and researchers, evaluation, evidence-based decision making, Ministerial inquiries, media requests and various cabinet documents (over 1,600 requests completed in the 14/15 fiscal year)
- Facts and Figures, Departmental Performance Reports, Annual Report to Parliament on Immigration, Performance Management Framework (PMF).
- Workshops , demos and presentation to enhance data use.

## External release of CIC data and stakeholder data access

- Review and approval of the release of all data destined to the Minister's Office, the media or outside CIC
  - While ensuring the proper information sharing agreements and authorizations are in place to enable data release and required compliance to the *Privacy Act* are met (about 3,000 requests completed in the 14/15 fiscal year)
- Enhance data format and incrementally add datasets to the Government of Canada's Open Data website – [www.data.gc.ca](http://www.data.gc.ca) (as per TBS Open Government Directive)
- Ad-Hoc External Statistical Requests:
  - Requests for existing records containing statistics may be made through the Access to Information process.
  - Statistics previously not-published may be requested through CIC's external data request mailbox ([statistics-statistiques@cic.gc.ca](mailto:statistics-statistiques@cic.gc.ca)) as per section 314 of the *Immigration and Refugee Protection Regulations*, where a cost recovery fee might apply. Media relations is advised of any data being released to media.
- Negotiate information sharing with various stake holders (e.g. provinces/territories, City of Toronto, Manitoba Centre for Health Policy, research networks, etc.) to support research data release and enable information sharing of research and statistical data.
- Continue collaboration with Statistics Canada's Research Data Centres to provide researchers with secure access to CIC Permanent Residents/Landings data.
- Monthly and quarterly delivery of PR and TR research data to the provinces/territories.

# Meeting current and future labour market needs

## Permanent Residents

### **Understanding the impact of the Express Entry system on the labour market**

- Development of Express Entry (EE) Performance Measurement Data, including development of regional indicators in collaboration with PTs and design of online outcomes survey
- Assessment of EE-Comprehensive Ranking System (CRS) effectiveness; modifications required to move to a single economic stream; investigation of CRS impact on application pool; and, identification of international student use of EE

### **Support levels planning and Express Entry with levels scenarios, alternatives and/or impact assessments**

- Produce Reference Case for 2016 and 2017 levels plans; investigate optimal size and timing of Invitation to Apply (ITA) rounds; investigate applicability of a 70:30 immigration category split at the national level, in collaboration with provinces/territories; and, examine implications of rising inventories for provincial nominee & inland/overseas spousal applications

### **Maintain Labour Market Information (LMI) in support of MTP and strategic planning**

- Update IMDB Research Suite: Core report and Category Profile; leverage Evidence Base for Levels and Mix product suite and OECD Country Review of Labour Migration to Canada; and, produce quarterly Labour Force Survey (LFS) Dashboard updates

## Temporary Residents

### **Assess overall impact of TFWs and IMPs (by stream) on labour supply and demand (person/year and duration calculations), displacement of Canadian-born workers**

- Investigate the role of temporary residents by industry of employment, occupation and region

# Leveraging Research Partnerships and Knowledge Management

**Enhance existing partnerships and develop new and strategic policy-relevant partnerships to promote CIC research priorities with other government departments (OGDs) and research networks to augment CIC's evidence base:**

- Research Partnership Table (tangible link between CIC and the research community)
- Develop an Official Language Minority Communities (OLMC)-research partnership network to collaborate with researchers in this field
- Develop strategic policy relevant Research Undertakings with researchers, research networks and OGDs (e.g., Conference Board of Canada)
- Collaborate with Statistics Canada on the piloting of the Permanent Resident file in the Research Data Centres
  - Conduct an assessment of the pilot project in collaboration with Statistics Canada , assess research proposals requesting access to CIC data, and provide support to answer subject matter specific questions from researchers

## **Develop collaborative spaces**

- Institutionalize exchanges of knowledge products with internal and external partners/stakeholders
  - Create a centralized repository in the Research & Evaluation Branch (R&E) GCDocs environment to centrally archive research products
  - Setup and maintain a GConnex presence to connect with colleagues in other federal departments
  - Build a shared e-space for exchanges with non federal partners

## **Improve access to knowledge products via Reference Services**

- Develop a centralized access portal for published and unpublished knowledge products (available on CIC's Internet website; CIC's intranet website, Connexion; R&E's Wiki; and GCDocs environment)
- Promote within CIC available e-resources and print collections, access points to knowledge products, and research assistance services
  - Communicate a one-pager overview of Reference Services to CIC employees
  - Individualize the Research Matters/For Your Information email announcements by creating distinct templates
- Leverage research partnerships for knowledge mobilization
