

Plenary: Canada's Role in Refugee Resettlement: A Vision for the Future

Pathways to Prosperity Board of Directors Meeting

P2P Workshop on Attraction, Retention, and Integration of Immigrants in Smaller Communities

On October 7, Pathways to Prosperity, in partnership with the Atlantic Region Association of Immigrant Serving Agencies (ARAISA) and the Association for New Canadians (ANC), hosted a full-day workshop in St. John's, Newfoundland, on Attraction, Retention, and Integration of Immigrants in Smaller Communities. More



than 60 participants attended the workshop. According to the evaluation survey, overall the workshop was very interesting, useful, covered a good range of topics, and had good quality discussion, with mean ratings above 5.5 on a 7-point scale for all of these evaluations. In addition, all of the panel sessions received mean ratings above 5.7 on the 7-point scale, as did the majority of the breakouts. Comments were also interesting, with a range of suggestions that we

will try to incorporate in future events. We would like to thank all presenters, chairs, and facilitators who worked so hard to ensure that the workshop was a success.

Projects Funded Through 2016 National Call for Proposals

In May 2016, a call was issued for projects bearing on the P2P's national research themes. Support was offered for initial research projects leading to larger, cross-regional projects for which outside funding would be sought. The research was required to have a policy or practice component, and eligibility was restricted to projects led by P2P collaborators or partners. The selection committee comprised Herbert Schuetze, Danielle Gaucher, Michael Haan, Jean McRae, and Victoria Esses. The three successful proposals are:

1. An Examination of Racial Micro-aggressions among Refugee Youth in Two Canadian Cities

Researcher: James Baker, McMaster University

This project aims to assess the prevalence and effects of racial "micro-aggressions," defined as brief, daily, verbal or non-verbal exchanges that communicate negative views, ideas, or beliefs to people of colour because they belong to a racial minority group. The study will involve a community sample of about 30 to 40 young refugees, aged 14-25, who have resettled in St. John's, Newfoundland and Labrador and Hamilton, Ontario. In comparison to St. John's, which receives relatively few refugees, Hamilton, as a significant refugee receiving city, may provide these youths with more formal and informal networks to mediate, make sense of, and manage micro-aggressions. Thus, the research will compare young refugees' experiences in these two cities in order to explore the ways in which local context shapes the experiences of, and responses to, racism.

2. Exploring Immigrant and Refugee Students' Experiences of Belonging: The Open Studio Project

Research Team: Heather McLeod, Leah Lewis, and Xuemei Li, Memorial University

This project takes a collaborative community arts based participatory action approach, using the Open Studio process as its central framework. It will engage immigrant and refugee students in an after-school Open Studio group process, where themes of inclusion and belonging will be explored. Outcomes will be presented in the form of a student-curated art exhibition. The research component will include an initial needs assessment, two focus groups: the first at the start and the second towards the end of the Open Studio process, and semi-structured interviews of the participants. The project will be conducted in collaboration with a local St. John's high school, Holy Heart of Mary Regional High, currently hosting a sizeable representation of immigrant and refugee students.

3. Examination of Older Immigrants' Contributions to Canadian Society: A Pilot Mixed Method Study

Research Team: Ping Zou, Nipissing University, and Tony Fang, Memorial University

This study examines older immigrants' contributions and strengths, which are important but often neglected components of their integration process. The findings of this study will help older immigrants to better integrate into Canadian society through a better recognition of their important roles, promotion of respectful social environments, and reduction of discrimination. The study will also explore new strategies and services for older immigrants, including the benefits of switching from problem-based interventions to strength-based approaches. The sample will consist of 100 immigrants, aged 65 years or older, and living permanently in Canada. They will be recruited from diverse immigrant communities in the Greater Toronto area. Quantitative data will be collected and analyzed; then qualitative data will be obtained to extend, expand and facilitate the interpretation of the quantitative results.

Update: Pathways to Prosperity Standing Committee on Student Engagement

Claudia Prévost is a PhD candidate in Ethnology and Heritage at Laval University in Québec City. Her doctoral research focuses on Bhutanese refugees' social process of learning French after resettlement in Québec City. She has also studied the impact of cultural mediation practices in intercultural contexts. She currently works as Research Coordinator on a project aimed at documenting factors that facilitate and constrain communication and collaboration between therapists and immigrant parents raising a child with a disability.





Serperi Sevgur is a PhD candidate in the department of Sociology and Social Anthropology at Dalhousie University. Her PhD thesis is on Georgian women who work and live in Turkey. Serperi is in the process of analyzing her data collected via qualitative methods during field work. Her research interests range from the migration of the highly skilled in Canada to global feminization of migration.

SCSE co-chairs are the official liaisons between the Committee and the P2P co-investigators and representatives for P2P subcommittees and all P2P

events. We would like to thank Claudia and Serperi for taking on this important leadership position and for their valuable contributions as members of the committee over the past years.

The Committee recruited four new members over the past couple of months: Awish Aslam (PhD Student, Western University), Aasa Marshall (MA Student, University of Saskatchewan), Cavita Meetun (MA Student, Western University), and Brenda Taylor (MA Student, University of Saskatchewan).
