The Cost of Not Providing Access to Interpretation

- LEFP clients have a 63% greater chance of readmission to hospitals when interpretation is not provided
- Typical hospital stay is 3.5 days longer for LEFP clients
- Misdiagnosis and wrong treatment is also high due to language barriers


"Having professional medical health interpreters present within the healthcare system can significantly improve LEFP clients understanding, help establish diagnosis and treatment plans which reduces disparities"

Why The Need For Professional Interpretation Services

- LEFP clients have a lower rate of participation in healthcare programs in comparison to general population
- Language barriers and limited literacy capacity
- Safety concerns (lack of training for ad hoc interpreters, lack of familiarity understanding of specialized medical terminology)
- Equity concerns (quality of services provided)
- Client compliance
- Confidentiality
- Burden on family and community to provide interpretation

Local Immigration Partnership (OLIP) Champlain LHIN funded regional program Became operational in 2016 Objective to increase access to professionally trained healthcare interpreters for vulnerable LEFP



"A social enterprise is an ongoing organization or venture that incorporates earned income strategies to achieve a social mission."


Centre Social Enterprise Development (CSED)

- Cost neutral plan, profit generated from social enterprise reinvested into program growth


BUSINESS MODEL

- We are embedded in the healthcare sector (part of SWCHC)
- Our model includes subsidy support for programs
- We provide subsidized interpretation training program, crucial to quality of service delivery
 - CILISAT/ILSAT Certified
 - Core Community Interpreter Training
 - Medical Terminology Training
- Our interpreter are covered under errors and omissions insurance
- We continue to provide the lowest rate to ensure equitable access to interpretation services
