
# Impact Summary Report for the Immigration Partnership's 2014-2016 Community Action Plan



This report provides a summary of the impact that the Immigration Partnership's (IP) 2014-2016 Community Action Plan (CAP) has had in the community. The results are taken from a survey of IP partners of which 66 partners responded (63% response rate).

#### **Demographics of IP survey respondents:**


All groups across IP are represented in the survey results, as seen in Chart 1.




About half of survey respondents have been involved with IP for more than 2 years (51%) (see Chart 2).

About 35% of survey respondents came to Canada as an immigrant (32%) or refugee (3%).

IP consists of partners from a variety of sectors across Waterloo Region. The largest sector represented among survey respondents was community members (24%) and those working in social services (25%) (see Chart 3).





## Impact of IP partner engagement

#### Impact of the CAP actions

In general, the majority of survey respondents indicated that CAP actions have made a positive impact for immigrants and refugees. For each action area, partners were asked whether the action has had "no impact", "little impact", "some impact" or "great impact". The most common response was consistently "some impact" across all action areas. The action areas within the Settle pillar were more often rated as having a "great impact" than were the action areas in the Work and Belong pillars (see Table 2).

### **Examples of how IP has made an impact**

Survey respondents shared examples of how they know we've had impact. We know we've had an impact because of:

- new system changes (e.g., in hospitals, schools, WWLHIN)
- more immigrants in leadership (e.g., MPs, Boards)
- more coordination of services
- more awareness of issues (e.g., I Am WR)
- greater engagement across community (e.g., coming together for the Syrian refugee influx)
- a better understanding of systems and supports for immigrants

#### Examples of how IP could have greater impact

Although we know we've made an impact in certain areas, we know there are things we can do in order to have a greater impact. Suggestions made by survey respondents include:

- more promotion of diversity and inclusion (e.g., with employers, mainstream service providers, health care providers)
- focusing on fewer actions
- decisions on actions being made by those carrying out the tasks
- more media coverage (e.g., radio, social media, news)
- wider engagement of decision-makers (e.g., levels of government, Board of Education)

#### Impact of Syrian refugee influx on the CAP & IP

IP partners recognize that the influx of Syrian refugees in Waterloo Region in 2015-2016 has had a profound impact on the entire community, IP and the progress of the CAP actions. Impacts noted by survey respondents include:

- Renewed community interest in refugee concerns
- Successful community coordination
- Greater awareness of IP and the need for a forum for collaboration and partnership
- Demonstrated that IP is a community leader and is responsive to community needs
- Some CAP actions received less priority and were delayed
- Strengthened relationships
- Broader community engagement

#### Conclusion

Overall, these survey results show that there is a tremendous amount of impact that the Immigration Partnership has had over the last few years. While it is encouraging to see the progress that has been made towards achieving our vision of making Waterloo Region a community in which immigrants and refugees successfully settle, work and belong, we know that we still have a long way to go and much more collective effort is needed before we truly reach our goal.
